



Achieving the NHS Five Year Forward View (2014-2019)



For the NHS to meet the needs of future patients in a sustainable way, we need to close three gaps:



Integration of pharmacist roles into the wider healthcare system

- NHS are pushing and promoting pharmacists and pharmacy technicians integration in primary care as part of <u>multidisciplinary healthcare teams</u>
- □ Focus on the clinical roles that pharmacists and pharmacy technicians have
- Evaluation of impacts key to support sustainability

Pharmacist Prescribers working in urgent care centers

Overview of the role of pharmacists in integrated and collaborative healthcare settings

- Pharmacists will form part of multi-disciplinary team in a patient facing role to clinically assess and treat patients using their expert knowledge of medicines for specific disease areas
- Proactively manage people with complex polypharmacy especially elderly, care homes, multiple co-morbidities
- □ Medicines advice helping address both public health and social care needs
- Leadership on medicines optimisation and quality improvement
- Further integration of the health care system with wider healthcare teams including community and hospital pharmacy
- Pivotal role to improving the quality of care and ensuring patient safety

Patient facing clinical roles

- □ Long term conditions
- □ Clinical Medication Reviews
- Domiciliary and Care Home visits
- Other appointments e.g.
 Cardiovascular Risk checks,
 advanced minor ailment
 support



Medicines Optimisation

- Repeat prescribing process
- Triage and liaising with other healthcare professionals
- Medicines reconciliation and polypharmacy
- Clinical effective audits and interventions



Medicines Support

- Telephone consultations
- □ Any medicines related issues
- Vulnerable populations e.g. mental health
- Medicines informationEducation to all staff



Clinical Post/Admin and Pathology

- Checking and reviewing
- Actioning clinical post
- Triage
- Requesting pathology (e.g. drug & long term condition monitoring)




Productivity, access and research

- Leadership and management roles
- Innovation and research
- Business modelling and productivity

- Help join up primary and secondary care
- Mental Health Services
- Social Care Services
- Community pharmacy
- Hospital pharmacy
